### **What Is Ownership?**

**Responsibility – Control** Of Usage – **Rightful** Possession,  
For An Individual's OWN **Property**

### **What Is NOT Ownership?**

Giving away responsibilities, to others, that only you can truly be responsible for. Giving away ownership over, to others, something that only you can truly have ownership over.

### **What Is A Right?**

From Merriam Webster Dictionary: Qualities, such as **adherence to duty** or **obedience to lawful authority**, that together constitute the ideal of *moral* propriety or merit *moral* **approval**. Something

to which one has a *just claim*. The power or **privilege** to which one is *justly entitled*.

### **What Is A REAL Right?**

Any action that is NOT a Wrong. A Wrong action is any action which results in harm, any form of *theft*. **Morality is not legality**, just because something is “legal”, does not make it Right. Wrong actions include Murder, Assault, Rape, Theft, Trespass, Coercion and Willfully Lying. Murder is the theft of one’s OWN life which is not rightfully ours to take, Assault is the theft of one’s OWN well-being without right, Rape is the theft of one’s OWN free-will sexual association, Theft is the stealing of one’s OWN property, Trespass is the theft of the security of one’s OWN living domain, Coercion is the theft of one’s OWN free-will choice via violence or duress, Willfully Lying is the theft of necessary information which negatively impacts one’s OWN ability to engage in their OWN informed decision making. To do Right and not to do Wrong, to act in harmony with Natural Law, is to not steal. Some form of Property is always being stolen when a Wrong action is committed. No victim, no crime. Your Rights, being a form of property, belong to you as a birth-right. All Rights are property Rights. Slaves do not know or act on behalf of their Rights.

### **Can Slavery Be A Right? How Was It Justified?**

It can only be a legal “right”, it can NOT be a REAL Right. Enslavement is the continual claim for the theft of one’s OWN property. Another being does not belong to you, just as a form of theft is taking something which does not belong to you. Even if we don’t accept the premises of “Rights”, we can understand why *abolitionism* was done in the past for general moral and ownership purposes. Legality can NOT become morality, turning Rights into privileges that must be “granted” or “revoked.” One can only claim to do this and convince others that it is legitimate. Legality as imposed morality, is claiming the theft of one’s OWN moral compass, conscience and freedom of choice. It does not

matter how people have justified Slavery in the past, because the act itself is a claim of ownership over somebody who does not belong to the claimant. Justification comes from the Latin noun *jus*: “right” and the Latin verb *facere*: “to make, to create”, meaning “to *create* a right”, even if it isn’t actually Right. Slavery is not the only example of an act that is Wrong gone unaddressed, as Democide, the top cause of unnatural death, is known as “death by government”; it is responsible for deaths carried out in the name of “following orders”, often for the “greater good”, thereby suppressing individual’s OWN moral compass or conscience questioning if the individual action should actually be committed or condoned. A Wrong is always Wrong, a Right is always Right, even if it takes centuries to find this out and align our actions toward it, chaos will ultimately ensue in our ignorance, to teach us our Wrongs. Then, knowing how exactly such Wrongs have manifested, can prevent the chaos from happening again. Slavery can be put to an end, for actual Right.

### **What Is A Claim?**

An imposition, declaration or demand based either upon belief or knowledge. Just because an action can be committed, does NOT make it Right, another word for correct. A claim over property that belongs to you, is just, correct, Right. A claim over property that belongs to someone else, is unjust, incorrect, Wrong.

### **What Is Equality?**

The condition in which everyone has the same Rights. A condition of which no Slavery is present. Since Rights are a birth-right, this would mean people are born equal by their base-nature of everyone sharing humanity. No one person can have any more

or less Rights than anyone else. People can only be kept away from exercising their OWN Rights, by others doing Wrong to them or by their own belief that they need permission from an “authority” in order to exercise a Right. Any action that is Right, is an action that promotes equality. Think of the golden rule taught across nearly every culture, do unto others what you would want done unto you.

### **What Is Inequality?**

The condition in which some people claim to have more rights than others. A condition of which Slavery is present. This would mean that Rights are not respected as a birth-right, and are instead treated as privileges, assuming that some people have the Right to “grant” and “revoke” other’s Rights, assuming that those with this “authority” are more-human or a special-kind of human in order to do so. This creates a dynamic where those of less Rights are not *allowed* to conduct actions that those of more Rights could exercise. You require permission to be free from the chosen, and the most freedom is for the chosen. For Slavery in the past, the “granting” for the freedom of Slaves was known as manumission or enfranchisement.

### **What Is Freedom?**

The condition for what one is able to do or has permission (hence “permits”) to do under their current legislature “authority”. It is to be cited in fancy pieces of paper with writing, that this individual is able to pursue what the legislature “authority” *provides* to them, thus assuming man-made rights and man-made law.

### **What Is REAL Freedom?**

The condition of freedom is the absence of Slavery. Freedom includes infinite possibility, including the possibility of chaos that may attempt to limit freedom. The ability to live your life as you so choose, since it belongs to you. Freedom, however, is not free. It is your property, therefore it is your responsibility to understand ownership and be responsible for your own freedom. Freedom,

being a birth-right property, is therefore natural and destined for your own life. You must OWN your OWN freedom, by knowing how to manifest and maintain it. Any voluntary interaction is a freedom-based interaction. The exercise of Rights is the exercise of freedom.

### **What Is Involuntary?**

An interaction of which is not consensual, an interaction done against someone's own free-will choice. This is an interaction against REAL freedom, as it is telling someone what to do with their OWN property of freedom, committing theft upon their Right to choose how to live their own life. It is backed by violence in it's proceeding. An involuntary action is therefore Wrong, making a claim upon the property of another, therefore legitimizing an act of Slavery.

### **What Is Violence?**

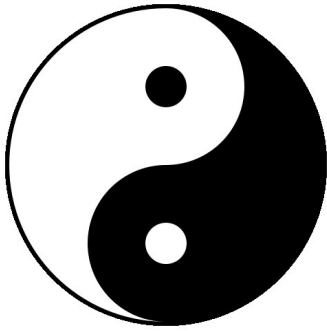
To *violate* the inherent Rights of other beings through theft, is actually what is meant to conduct *violence*. An act of violence is the immoral initiation of force to coerce, compel or restrain.

### **What Is Chaos?**

The condition of which Slavery and Violence is systemic, otherwise known as manifested evil; the result of imbalance, otherwise known as injustice.

### **What Is NOT Violence?**

The use of **force** for **self-defense** in retaliation to those who are actively committing the **violence**, as done by slaves of the past in order to **free themselves**. You can help other’s achieve their own freedom, but only you can *truly* free yourself. If someone refuses to be free or never embraces their freedom, they will never *truly* be free. However, you can voluntarily choose to help defend other’s freedom, against those who seek to do violence against them. This is the self-defense principle. To choose not to commit violence, is known as the non-aggression principle.

### **How Does Slavery Manifest?**

1. Mental Slavery → Physical Slavery
2. When the ACT of Slavery is committed and condoned

### **What Is Mental Slavery?**

The condition of unquestionable self-induced servitude, not being able to reason and think for yourself; the condition of mind control, leading to and maintaining physical Slavery. Many slaves thought they were meant to be slaves, unquestionable for them, a reality without it, therefore **freedom is feared** and security-dependence is embraced; it became normal for the lack of responsibility over their own property, as it wasn’t recognized and embraced as their own, it belonged to their “master.” Violence



isn't necessary if the slave complies on their own and becomes convinced of their own slavery and lack of need in freedom.

### **What Is Physical Slavery?**

The condition of violence-based compliance for servitude. Whether the slave is a mentally a slave or not, violence will ensure that the slave becomes mentally enslaved through the trauma of fear.

### **What Is Fear?**

The condition of an individual who can not be aware, as it has been shut down, vulnerable for what may influence them. Due to the lack of awareness, this condition manifests to ignorance, confusion, control and chaos. The only escape from fear is courage, the opposite of fear is love. A Slave owner doesn't truly love a human being that they consider less than human, or adequate for Slavery, by any means; this individual is in fear of losing their Slave-control, remaining ignorant of their own responsibilities and their Slave's own property. A Slave may never know real love, as obedience to authority is the only virtue, the only reward.

### **Why Is Slavery Bad?**

It is immoral, contributing to injustice within the world, ultimately leading up to chaos, as seen by the cruel hardships endured by slaves, the harsh punishments created by slave owners and the revolution attempts by slaves throughout history. However it does not matter which slave was punished more than another, if slavery is inherently immoral, such an action should not be committed or condoned at all. While mental Slavery may be a more covert form of overt physical Slavery in-reality, it must be addressed if it always leads to the condition of physical Slavery. The act contributes to the condition and vice versa, but any action first requires a mindset (mental state) that permits it.

### **Why Is Labor Important?**

What you produce is the fruits of your labor, you have ownership over this property. If taking 100% of someone's property is theft, what percentage isn't? If claiming 100% ownership of someone's property is Slavery, what percentage isn't? Taxation is one of the greatest examples of theft, dressed up in a new word, written on fancy pieces of paper and covered with justification. Physical Slavery is having someone work for you, with little to no pay and involuntarily; theft is having someone pay you and involuntarily. The big issue to spot here is that both situations are involuntary, therefore, both involve a lack of freedom, and the need for violence for compliance. You may get no pay, and physical slavery becomes just as bad as theft itself, but slavery is still a form of theft because you don't have a choice in your labor, and if you are physically enslaved, what can you do with your pay? Ownership over the property of your life is the ownership over the property of everything else within your life; what is yours is yours unless you voluntarily give it away, anything else is mental or physical Slavery.

### **What Is *The Source*?**

Nature – Birth. Otherwise there can be no foundation for knowing and applying rights, freedom, equality, slavery etc. Otherwise everything is based upon man-made whims and opinions, regardless of real-world consequences due to Natural Law, such as the condition of chaos. If we want a better world, we must know what is Right, learning the effects to our behavior overtime; this is learning from history, so not to repeat it.

### **How Does Someone Become A Slave?**

Mentally or physically, for servitude. Either they are convinced to be a slave, mentally for them-self or for others, or they are violently complied into being a slave, physically. People have historically become physical slaves as result of government war or government jailing systems. Children of slaves became automatic slaves.

## **Is Slavery Natural?**

It is not *Reality*, it is based upon belief. Nobody is born a slave by nature, they become a slave due to man-made imposition. A Right is an action which doesn't violate the nature of another, and the nature of people are to simply be people, not cattle for other people who are technically the same as them: humankind. The fact Slavery was a part of a way of life, even being born into a slave-family, made the practice seem legitimate, until the application of human natural Rights and Natural Law in the 18<sup>th</sup> and 19<sup>th</sup> century. All that came with slavery was seen as natural, as a result. From mass long-endured unpaid labor, to severe punishment, to prisoners of war, to obedience to "authority," it was seen as practical for the growth of society, even if it was at the cost of other's freedom, other's lives.

## **What Is Belief?**

It is a supposition without *knowledge*, or it is an opinion. It is an acceptance that something exists, even if it may not. If more knowledge was present, it would be less of a belief. If one doesn't know, they won't say "no." *Belief* can often be a *lie*. Belief systems are often responsible for the close-mindedness of individuals, the many forms of man-made religions, from man-made money, which people believe in, to the theater sports game of man-made politics, which people believe in. What people believe in, will occupy much of their life, via time and attention, the real currency. If an individual maintains an opinion, which people will have, is it Right to impose that opinion on others, essentially imposing their will on others? It is never Right, as to impose would mean that it is involuntary, and that is the theft of the individual's property of freedom to live life as they please. The slave master is able to impose their will upon the willing slave, as much as they please. The slave may beg for change, but that simply legitimizes their condition of being a slave, needing to ask for permission to exercise a Right; therefore the slave is in a mindset of mental Slavery, a belief that they must maintain their

situation even if it can be made better. This slave however does not have the knowledge, or is ignorant of the knowledge, that the situation they are in is inherently immoral and cannot be changed, it *must* be *abolished*. Similarly, a myth or superstition is a long held false belief.

### **What Makes Slavery Seemingly Part Of A Way Of Life?**

It is commonly known throughout history as an “established institution”, supposedly necessary for productive businesses and trade. It is widely accepted that certain individuals have less Rights than others. Individuals were taught to believe Slavery was essential or natural to society.

### **When Was Slavery First Practiced?**

The following is all mainstream, and not a theory. In order to understand the “established institution” of Slavery, we need to go back to the roots of humankind. BC (Before Christ) & BCE (Before Common Era) are the same, counting down, before the year 1. AD (Anno Domini) & CE (Common Era) are the same, counting up, after the year 1. BP (Before Present) is before the year 1950 AD/CE. Humans supposedly first appeared on earth around 300,000 years ago in the Middle Paleolithic Stone Age, which was from 300,000 BP to 50,000 BP. The first and oldest formal government was known as the Sumerian Empire or Ancient Mesopotamia, first settled between 4500-4000 BC. This is also when systemic slavery was officially first established. Therefore, if we do the math, it has been about 6000+ years since the first form of government. That means, for about 294,000-years human beings lived without any form of government or systemic slavery, that we can take note of. People may attribute slavery with the growth in population, however slavery was due to the lack of morality (via imposed moral relativism), the focus on centralization and collectivism, the result of war or the monopoly on violence, the obedience to presumed “authority” and the growth of mass agriculture and industry resulting in soil nutrient depletion and pollution. In Sumeria, the authority of

“rulers” or “masters” was seen as legitimate as they had the supposed “divine right to rule”, being the priest class above others who were not. This “right to rule” doesn’t exist by our definition of Rights, there is no such thing as the delegation of a Wrong, it is a claim of ownership over another’s property, it is theft, it is immoral. Nobody can be born into this world as a “master” or vested “authority” unless they are able to convince others that they are a special kind of human, as done in Sumeria. This “authority” isn’t a Right they are born with, it is a Right that never can and never will exist, it is entirely of belief. Some sources may claim slavery started around 11,000 years ago in the Neolithic Revolution, however that’s only when the Neolithic Revolution first started in 10,000 BC. There is little to no evidence to be found of systemic slavery occurring until the founding of the Sumerian Empire, as slavery was practiced in *every* ancient civilization known thereafter. How can an “established institution” be founded without a system in place that makes it such? How can it be *systemic* without a *system*, especially as an unnatural condition? The oldest law codes of these ancient empires often convince the legitimacy of their system, the need for masters, proclaiming to be of equity and truth as it says in the law code of Ur-Nammu, or “to prevent the strong from oppressing the weak” as it says in the law code of Hammurabi. This is despite the existence and exercise of overt Slavery, while deciding for the slaves what their Rights are and deciding upon their own whims, what their punishments are to be. It did not matter what the slave masters decided to title themselves, whether they were Priests or Kings, or Priest-Kings, or what they tried to make sound just, as they were still engaging in the act of Slavery.

### **What Is A Bully?**

Someone who dominates or pressures over another, aggression often on a consistent basis, as a means of coercion if it is the act of bullying another into doing something. It requires an abuse and of power, whether it be of a mental expression or physical



expression. Therefore, it is this that the slave master has upon their slave. The most potent strategies against Bullies, is to walk away if possible or find a way to stand up to them, ultimately, the resistance to slavery, to where a bully becomes someone who cannot bully you anymore.

*“It should be stressed that ‘authority’ is always in the eye of the beholder. If the one being controlled believes that the one controlling him has the right to do so, then the one being controlled sees the controller as ‘authority.’ If the one being controlled does not perceive the control to be legitimate, then the controller is not viewed as ‘authority’ but is seen simply as a bully or a thug.”*

### **What SHOULD People Want Their Children To Learn?**

If parents have the ability to guide their children, which they shall, and if parents want the best for them, guiding them through their growth and decision-making, then parents will likely uphold the knowledge of basic morality and ownership. People generally *WANT* truth, equality, love, justice, order and freedom. How many actually teach it, is dependent upon how many people actually know it. We should want our children to know how to recognize bullying, to not be the bully and not be bullied. By knowing Slavery and what is wrong, it helps us know more of what is Right. Morality is the root to all injustice. If people truly care for their children, they want them to make the Right actions in life, to achieve a happy and healthy condition, not the wrong actions in life that lead to a slavish condition which is the opposite. Do no harm, but take no harm. Do not tread on me, but do not tread on anyone. Don't put people on pedestals. Simple principles, because justice is a natural principle, not law, unless it is “Natural Law.” In the condition of slavery, it is imposing man-made law for rules of behavior upon other people, where justice is according to whim and there are no principles. Rules often

become more and more complex overtime, as done by the many different forms of slavery and legal codes practiced.

*“Children learn the fundamental principles of natural law at a very early age. Thus they very early understand that one child must not, without just cause, strike, or otherwise hurt, another; that one child must not assume any arbitrary control or domination over another; that one child must not, either by force, deceit, or stealth, obtain possession of anything that belongs to another; that if one child commits any of these wrongs against another, it is not only the right of the injured child to resist, and, if 'need be, punish the wrongdoer, and compel him to make reparation, but that it is also the right, and the moral duty, of all other children, and all other persons, to assist the injured party in defending his rights, and redressing his wrongs. These are fundamental principles of natural law, which govern the most important transactions of man with man. Yet children learn them earlier than they learn that three and three are six, or five and five ten. Their childish plays, even, could not be carried on without a constant regard to them; and it is equally impossible for persons of any age to live together in peace on any other conditions.”*

### **What Is A Natural Leader?**

An individual who does not seek ruler-ship, but rather seeks to influence others. This is where knowledge is encouraged, because if an idea is so good, it does not need to be mandated, it can be taught. That takes work, but that's what creates a natural leader. This follows the nature of a guide or coach, inspiring others to be the change and find the inner leader within themselves. Health practitioners, doctors, teachers, parents are to fulfill this role.

**The Five Questions (By Larken Rose):**

- 1) Is there any means by which any number of individuals can delegate to someone else the moral right to do something which none of the individuals have the moral right to do themselves?
- 2) Do those who wield political power (presidents, legislators, etc.) have the moral right to do things which other people do not have the moral right to do? If so, from whom and how did they acquire such a right?
- 3) Is there any process (e.g., constitutions, elections, legislation) by which human beings can transform an immoral act into a moral act (without changing the act itself)?
- 4) When law-makers and law-enforcers use coercion and force in the name of law and government, do they bear the same responsibility for their actions that any-one else would who did the same thing on his own?
- 5) When there is a conflict between an individual's own moral conscience, and the commands of a political authority, is the individual morally obligated to do what he personally views as wrong in order to "obey the law"?

***The Seven Simpler Questions (By Brian Young):***

- 1) Do you have the moral right to rule or dominate another individual against their will?
- 2) Does anyone have the moral right to rule or dominate you, if you don't want them to rule or dominate you?
- 3) Does anyone have a legitimately higher claim over your life and property than you?
- 4) Do you have a legitimately higher claim over the life and property of another?
- 5) Do you have a legitimate right to steal your neighbors stuff?
- 6) Does anyone have the legitimate right to steal your stuff?
- 7) If you don't have the right to steal from or harm another person, can you confer that right (that you don't have) onto another person or group?

### **What Is The CONDITION Of Slavery (Enslavement)?**

A “condition” would constitute a systemic situation, based on repetitive or aggregated actions. Government is the condition of Slavery, as it provides a system for the systemic action of claiming ownership over the life of another individual or their property and the control over the life of another by threat of violence. The first and oldest government was the first and oldest condition of Slavery. This may come as a shock to some, but it is most evident. From the Latin verb *gubernare* (governo, governare): “to control” and the Latin noun *mens* (mentis): “the mind.” The etymological origin of the English suffix -ment is often debated, yet it is overwhelmingly clear that those who created the English language deliberately chose *mens*, the Latin word for “mind,” to mean “the state of or “the condition of,” in direct keeping with the First Principle of Natural Law (Hermetic Principles), the Principle of Mentalism, which demonstrates that in order for any particular thing, event, circumstance, state or condition to exist as it currently does in our manifested reality (the Plane of Effects), it must first have existed in mind (the Plane of Causality).

### **What Are The Symptoms Of Slavery?**

Control, war or conflict, trauma, fear (including the fear of freedom), democide and the lack of love, knowledge, sovereignty, freedom, and order. Other signs may include a lack of health, few possessions (or the lack of knowing or ownership thereof) or restriction of movement. These symptoms manifest in the macro and micro, otherwise known as the individual and collective. The conditioning of the condition of Slavery occurs where individuals may soon simply “follow orders” in order to get-by, even if the order is not Right, since morals are out of the question and outright violated.

### **What Is REAL?**

Anything that exists, based in reality, nature, the source. It is what is genuine, having physical existence, not created by belief, it is legitimized by knowledge.

### **What Is A State?**

Any “government” presuming to create the conditions on earth, a state created by belief, with no actual physical existence itself. It is simply people like you and I. They may use fancy clothing or fancy pieces of writing, but it does NOT legitimize an act of Slavery, it does not make people have more Rights than others or create Rights that don’t exist; this can only be believed to be legitimate, when in reality, it is not.

### **What Is A REAL State?**

An existing physical condition based upon action, based on a mental condition, based upon reason. This may be referred to as the mental state for the physical state. Human beings, being programmable like computers, are able to become conditioned to the conditions brought upon them, especially at a younger age. Nature is all there is, as a physical state or condition, as it is the real source, the eternal immutable universal condition. Any government state is assuming to be natural, when it is not; it is attempting to become the state of nature, where the slave only does what they are given permission to do by other beings in this system, determining what conditions should or should not exist thereof the power of “the state”; it is man ultimately attempting to play god, as the state knows what’s best for you, you must obey the state. A mental slave may say “the state should know what’s best for us”, that “the state can be made better with our help, it is our slavery, we the people”, but does it matter how much better of a condition a slave can make their slavery? How could the slaves be in charge, if they by definition of government, put others in charge of their own lives and property? The only solution is *abolition* of what’s fake, the illusion state, and the integration with what’s real, the natural state.



## **What Is A Law?**

Dictates based upon dogmatic beliefs, constructs of the mind, for dictating other's actions to take in their OWN life, complied with due to the fear of punishment, violence. It is never universal or timeless, it differs with location and changes with time based upon who's beliefs gets to be imposed as "law", disregarding morality or natural justice, ownership and Natural Law. A man-made "law" is unnatural law. Even if 99% of people agree with something, should their belief or will be imposed upon the 1%? If 99% of people get to be free, 1% have to be slaves, is that Right? If it isn't voluntary, it isn't consensual, it isn't Right, a Right can't be turned into a wrong, and nobody deserves to be a slave. If a man-made law is in harmony with real law, ownership, then it follows logically that it is redundant, since it is stating a law that is already-existing, inherent, and self-evident; therefore it is both irrelevant and unnecessary. If a man-made law is in opposition to real law, then it follows logically that it is both false (incorrect) and immoral (harmful), or in other words, wrong (NOT Right); therefore it can NOT be legitimately binding upon anyone. Slavery can never be freedom, they are exact opposites. If all Slavery, all government, is tyranny; no Slavery, no government, is liberty. All government is Slavery, no government is freedom, this makes sense. People will always make rules for their own property, but if there is no violence for compliance, if it is voluntary, if it's of their ownership, it is not slavery, it just people working together. Government, which creates man's law is therefore best referred to as slavery, since it refers to the specific practice, as opposed to what people would rather think it is. Endless bloodshed and Slavery was only ever the result of mass-belief systems of mind control, mental slavery for physical slavery. An "*authority*" is an *author* of man-made "law."

## **What Is A REAL Law?**

An existing condition which is binding and immutable, which means it cannot be changed, it abides by principle. In the case of Rights via Natural Law, it is based upon principles such as self-

defense, non-aggression and ownership, harmonized with and brought about with knowledge and understanding. It is universal and timeless, non-man-made, existing and applying anywhere in the world. Slavery is not natural because by it's nature, it's man's law that creates it. Natural Law implies that freedom, ownership and justice alike, is inherent, based in reality, not caused or created by humankind to fit whatever agenda they want to impose.

*Be sure to read all the previous concepts before moving on,  
Given our understanding of the previous concepts...*

### **What REALLY Creates Slavery?**

Government, being what Slavery really is, is simply based on mental slavery, leading to physical Slavery. It would make sense that people mentally *believe* in Slavery, so that they can physically *try* to *create* Slavery, even if it can never truly be a physical reality. This is why the mind of a slave is in constant conflict with that of the slave master, they ultimately desire to be free because they are meant to be free. They also become in conflict with themselves, their mind becomes at conflict with their physical body. The slave master may even have psychological problems within themselves, projecting their problems to their slaves, or developing psychopathic traits. Everyone deserves to be free from external rulers, but there still are rules for ourselves, our internal ruler, and we must *know* them ourselves, we must *know ourselves* (a master of self; self-mastery, self-ownership, self-government, responsibility), if we are to even be free to begin with. However, what *really* creates the external rulers, the external government? Mental Slavery is the root cause, mental Slavery is actually known as *statism*. It is *statism* that creates the government *state*. Statism is the *belief* that there is such a thing as "authority" vested in certain human beings, magically giving them the "right to rule" over other people. This "authority" means that certain people, who we call "government," have the "moral right" to issue commands to those whom they rule (those under

their jurisdiction: “to say what the law is”), and that their “subjects” (slaves) have a “moral obligation” to obey the arbitrary dictates (“laws”) set by their Masters. Most simply put, Statism is the *belief* in the legitimacy of SLAVERY. Without statism, there can be no slaves of masters, and therefore there can be no masters of slaves. The slaves must free themselves or with free people’s help, hence the cause for *abolitionism*. Those called “government” or “police” are no different from everyday people, otherwise such would be supremacy, inequality. 20<sup>th</sup> Century government policing has its roots in the “slave patrol” which would recapture runaway slaves, therefore continuing Slavery. It’s as simple as knowing our nature, as The Liberator newspaper motto states: “our country is the world – our countrymen are all mankind.”

### **Extra: What Is A Psychopath?**

Someone who has no empathy, who may engage in abnormal or violent behavior, considered a morally irresponsible person, mentally deranged, one who obeys his impulses regardless of social morals. A slave master often has psychopathic traits, even if it doesn’t always seem so obvious or violence is not committed by themselves personally. The slave may be considered the criminal for disobeying authority to be free, but perhaps they aren’t the real criminal after all. Similarly, a sociopath is an individual with an enduring pattern of behavior characterized by the disregard for, and violation of, the rights of others, disregarding Right and wrong. Psychopaths tend to be more deceiving and planned in their actions, therefore making better criminals. Sociopaths and Psychopaths, especially with slaves, will not *care* for *abolitionism*.

### **Extra: What Is A Gang?**

A group of people who regularly or particularly commit crimes, who claim ownership over different pieces of land. Slave masters claim ownership and by their practice, utilize victims, committing immoral acts, crimes.

*“What distinguishes a street gang from ‘government’ is how they are perceived by the people they control the trespasses, robbery, extortion, assault and murder committed by common thugs are perceived by almost everyone as being immoral, unjustified, and criminal. Their victims may comply with their demands, but not out of any feeling of moral obligation to obey, merely out of fear. If the intended victims of the street gang thought they could resist without any danger to themselves, they would do so, without the slightest feeling of guilt. They do not perceive the street thug to be any sort of legitimate, rightful ruler; they do not imagine him to be ‘authority.’ The loot the thug collects is not referred to as ‘taxes,’ and his threats are not called ‘laws.’”*

*“What literally happens is that one group of people issues a command, and their enforcers impose it upon the masses, by punishing disobedience. This is what the Mafia does, what street gangs do, what schoolyard bullies do, and what all ‘governments’ do. The difference is that when ‘government’ does it, it uses not only threats but also indoctrination, of both the enforcers and the general public. Where the message of most thugs is usually direct and honest (‘Do what I say or I hurt you’), the ‘government’ message involves a great deal of psychology and mind control, which is essential to making the state mercenaries feel righteous about inflicting oppression on others. The controllers in ‘government’ portray themselves as ‘lawmakers’ who have the right to ‘govern’ society, portray their commands as ‘laws,’ and portray any who disobey as ‘criminals.’ And, unlike Mafia ‘heavies,’ those who administer retribution against any who disobey the politicians are portrayed, not merely as hired thugs, but as noble ‘law enforcers,’ who are righteously protecting society from all the uncivilized, contemptuous ‘law-breakers.’”*

*“Even a gang with tanks, planes, bombs and other weapons has no power to control an armed populace for long unless it first dupes the people into believing that it has the right to control them.”*

**Extra: What Is A Monopoly?**

When there exists only one supplier for a type of commodity, creating dependency and eliminating competition. Many will actually define government as what creates monopolies, and the monopolies that have existed all received assistance from government. A popular definition of government is that it is a monopoly on violence, as akin, Slavery is seen as legitimate violence. It is also said that the only lasting cartels have been government cartels, referring to collusion and domination in markets. Freedom provides choice, Slavery provides no choice.

**Extra: What Is Brain Imbalance?**

This is when the human-brain high-order-thinking neocortex is imbalanced, either toward the left brain or right brain. A left brain imbalanced individual will seek power and control. A right brain imbalanced individual will be naive and follow orders. We want to be in control of ourselves while knowing what actions are Right versus what actions are wrong, this leads to a brain balance between the two hemispheres. While this science may have disputes, the concept of control and the lack thereof still holds true. Dependence or mind control comes from weakened, ill minds, or imbalanced minds, mental instability, related to insecurity.

**Extra: What Is Satanism?**

Based on Anton LeVey's works, generally practiced as a "do as thou wilt and that will be the whole of the law" doctrine but disregarding morality. It claims that might is right, upholding impulses rather than conscience or high-order neocortex thinking. It is simply atheism, in addition to self-preservation, survival of the fittest embraced by social humans. It is essentially the practice that there are actually no rules but what we create, it is of left-brain imbalance and ego, potentially validating the slave-master. Freedom isn't freedom if it's not for everybody and without self-control being recognized and taught. While there may be other



types of satanism, this is to demonstrate a common practice in a world, regardless of religion.

### **Extra: What Is An Illness?**

From ill, meaning morally evil or hurtful, unhealthy, sick. It makes sense to why the word unnatural may also then refer to being at variance with moral standards. Considering the fact that mental Slavery is a more powerful tool than physical slavery for control, as the slave has enslaved thyself, legitimizing evil hurtful behavior, Statism can be seen as the mental illness of mental slavery. The mental health crisis seen in the world and the impacts of diet and environment will play a toll in regards to Slavery, as an unhealthy slave will be easier to control and via dependence, mentally and physically. Like any illness, it must be diagnosed (*dia-gnosis*: by way of *knowledge*) and treated at the root cause (by asking *why*).

From The Conscious Resistance, Danilo Cuellar states “The illusion of freedom is a more powerful tool to manipulate and subjugate a populace than any gun or stick can ever be. Guns can run out of ammunition and sticks can be broken, but mental enslavement to authority endures the ages. By this method the people will submit because they have been bred and programmed to do so since before they could talk or reason. They know of no other relationship than that of master and slave or ruler and subject. They grow to adore their servitude and reproach anyone who would seek to criticize their master just as a dog jumps with excitement when his master fills his food bowl and faithfully guards him against invaders. The main difference is that we far outnumber our oppressors and yet we tolerate their abuses because we cannot conceive of a world without their arbitrary restrictions and sundry taxes. We genuinely believe that it is necessary and moral for a society to rob its brothers and sisters to fund projects that are neither wanted nor useful. To deny the people the freedom to do with their currency what they will is the foundation for tyranny of the most egregious form, for with that

currency “government” may fund it’s own expansion and thereby continually justify it’s own existence through the Hegelian Dialectic.” (Hegelian Dialectic: controlled opposition of one side against another in a division; intentionally creating a problem, expecting a reaction, to implement an agenda-oriented solution)

### **Extra: What Is Cognitive Dissonance?**

When a current belief is in contradiction to new-coming knowledge and the individual cannot accept anything other than their current belief. This is mental slavery to an individual’s own thoughts. In light of an individual’s previous positioning, it creates uncomfortable feelings, ignorance and justification. If a slave master was long as slave master, long promoting it, it’s unlikely they will give it up easily. The same goes for a slave, long legitimizing their slavery and trained into such, it’s unlikely they will want to embrace real freedom. Since the slave has never lived real freedom, it is fearful, especially if the slave master can convince the slave that freedom is chaos, to be avoided in the comfort of “security.” When facing Statism, there will surely be cognitive dissonance, denial and contradictions. Most people at heart know that violence and Slavery is wrong for example, yet they will allow it if done by “government”, creating a contradiction in need of honest recognition if there is to be any healing via self-control and self-assessment.

### **Extra: What Is Self-Loathing?**

The underlying psychological condition that causes people to attempt to abdicate their own personal responsibility to exercise conscience (common sense) in choosing right over wrong, and fall into patterns of order following and justification. Just as it is not possible for an order-follower to truly be exercising conscience, it is not possible for an order-follower to truly love themselves. Self-Loathing is created when an earlier trauma has been suppressed and buried into the subconscious mind, instead of being confronted, dealt with, and healed. Such trauma could take the form of feelings of inadequacy, whether real, suggested,

or imagined. “They are in the cage, and they love being in the cage.” The only kind of people that have no desire for real freedom, it maintains mental slavery. Self-Respect (*re-spectare*: “to take another look”) heals Self-Loathing. If you don’t have \$10 in your pocket you could impossibly give it to someone else; you must obtain it first, before you can give it away. Therefore, nobody can give respect to anybody else unless they first developed it inwardly. It may have been hard to convince for *abolitionism* back then in a system of overt Slavery, and it will be hard now in a system of more covert slavery. As Slavery has continued in it’s many forms, it has gotten less harsh overtime as the aggregate moral growth in society grows, but we ought to make sure such growth is still occurring if we want to achieve our fullest potential. More moral society, more freedom; less moral society, less freedom; evolution, not involution. There may be an abundance of mindsets to diagnose and characterized behavior in effect for both the slave master and slave.

### **Extra: Why Do People Seek Ruling Over Others?**

Knowledge as power, as that of knowing the cost of freedom, can be used for good or for bad, depending on those who have such knowledge, if they use it for empowering all people’s freedom or manipulating others for their own freedom, but that doesn’t change the nature of the act of Slavery. When people are insecure of themselves, they may seek power through a form of Slavery, government, for their false sense of *security*. Usually it is related to an individual’s upbringing and youth. If an individual is lacking a father-like source figure, they will want a protector. If an individual is lacking a mother-like source figure, they will want a care-taker. Some individuals don’t have such needs, simply desiring a less abusive form of Slavery for themselves or others, since their mental slavery of Statism cannot get them thinking of the possibility of having no masters at all. Slavery will never provide REAL security, as there will never be sovereignty, self-ownership and self-defense for property that belongs with you. Knowing the nature of power itself, is enough to know of

how it cannot be trusted upon any individual or group of individuals, and how it naturally corrupts even the best of people, always resulting in chaos. It is giving an individual the non-existent Right to be a slave master. However, as much as people may want to blame those “in power”, the blame or culpability belongs on those who “give power”, that being the everyday mass public. One presumed slave master can give an order to a hundred slaves, and it is ultimately the choice of the slaves if they should carry out the order; if they do, they are the ones responsible, since they carried it out. The average person generally does not want to rule over their fellow man, for usually good reason. They may even know how bad the condition of Slavery is, talking about how it must be changed. What they don’t realize is that it is Slavery and the only way it can be changed is through *abolitionism*. A controlling person by definition is someone who demonstrates abusive behavior, coercion and violence; to seek any form of government is no different. Narcissism is also at play for the seeking of power with insecurity, as it involves a sense of superiority, need for admiration, and a lack of empathy, valuing people less than others. Ultimately however, no government power can be given to individuals who seek power unless by Statism, mental Slavery. People shall never give someone the Right to be a slave master to make them slaves, because in reality, that is Wrong and can never be legitimately done.

### **What Is Dependence?**

A lack of self-control, of independence, and therefore the seeking of external control, giving-in to an oppressor or provider. It is mental slavery. When security is placed externally, it implies a lack of security internally, creating a false sense of security that is an attempt to abdicate responsibility. If a slave never comes to secure their own self, their own freedom, their own ownership, they will never be free; freedom relies that the slave no longer needs a slave master or slave handlers to defend thyself. The undying obedience to authority is also demonstrated by Dr. Stanley Milgram and his experiments, which is documented in his

book “Obedience To Authority”. Since government provides no resource in nature, and only acts as the transfer of resources, everything that government provides to someone has been stolen from someone else. People can help voluntarily, but they may be giving you help at the expense of another, involuntarily, if one does not know how they are being helped and why. Asking why gets to the root cause of the symptoms, it is what the symptoms depend on. Why does government provide? To keep people in trust with their mental Slavery. How does government provide? Theft, by keeping people in fear, mental slavery, of punishment, physical slavery, if they do not comply with demands. Therefore, government exists and grows out of mental slavery leading to physical slavery, government is slavery.

### **What Is Self-Government?**

This is self-control. From the definition of government, self-government would mean self-mind-control, which makes sense as only we can truly be in control of our own mind. We are not fully instinctual animals, barbaric always seeking for power, we have a moral conscience to choose Right over wrong, and if we choose to continue to develop it as a species, we would create the opposite condition of slavery, where individuals are able to control themselves, real self-government. We can put the past behind as we are developed beings with the capacity of reasoning, unless we are to stay suppressed in our reasoning and knowledge, making us more susceptible to government Slavery. Those who do not put in the effort of making real freedom possible because they think humans will never be able to be sovereign, are enforcing mental slavery in their hopelessness, a slave that will never truly be free. If external government doesn’t exist in reality, self-government being the only government is simply the self, there is no government in reality.

***Therefore:***

**Government Created Slavery, Government Is Slavery**

Statism, Mental Slavery, Creates Government, Physical Slavery.

Government Depends On Statism, Statism Depends On You.

*Free By Nature, Slaves By Government.*

**But Without Government...?**

Government is not a “necessary evil” as some people may claim, because the same argument could’ve been made for more overt slavery in the past. It is no coincidence that the same exact arguments against the abolition of Slavery are the same exact arguments against the abolition of government. These arguments would be made by an individual who is of mental slavery, Statism.

*Claims made against abolitionism:*

- Slavery is natural – Government is natural
- Slavery has always existed – Government has always existed
- Every society has Slavery – Every society has Government
- Slaves are not capable of taking care of themselves – People are not capable of taking care of themselves
- Without masters, the slaves will die off – Without Government, the people will die off
- Where the common people are free, they are even worse off than slaves – Where the common people have no government, they are much worse off
- Getting rid of Slavery would create great bloodshed and other evils – Getting rid of Government would create bloodshed and other evils
- Without Slavery, the former slaves would run amuck, stealing, raping, killing, and generally causing mayhem – Without Government, the people would run amuck, stealing, raping, killing, and generally causing mayhem
- Trying to get rid of Slavery is foolishly Utopian and impractical; only a fuzzy-headed dreamer would advance such ridiculous proposal – Trying to get rid of Government is foolishly Utopian

and impractical; only a fuzzy-headed dreamer would advance such ridiculous proposal

- Forget *abolition*, a far better plan is to keep the slaves sufficiently well fed, clothed, housed, and occasionally entertained and to take their minds off their exploitation by encouraging them to focus on the better life that awaits them in the hereafter - Forget *anarchy*, a far better plan is to keep the slaves sufficiently well fed, clothed, housed, and occasionally entertained and to take their minds off their exploitation by encouraging them to focus on the better life that awaits them in the hereafter

- Without Slavery, who will pick the cotton – Without Government, who will build the roads

- There will be slavery anyways – There will be Government anyways

## **What Is Anarchy?**

Whatever you want to do, chaos. As a political doctrine, it will be defined arbitrarily and include personal tag-preferences.

## **What Is REAL Anarchy?**

From Greek *an-archon*: “the absence of rulers.” Just as monarchy comes from *mon-archon*: “one ruler.” It does NOT mean without rules, as to even attain the condition of anarchy, one must *know* the rules, past the *belief* that rules must only come from man-made rulers. Since nobody is ruling over anyone else, the state is freedom, nature. If people don’t know of Statism and continue having a Statist mentality, systemic Slavery will keep rising again and again. Anarchist is simply another word for Abolitionist, when we refer to this specific definition. However, for the sake of making our intentions clear, in knowing that freedom isn’t free, that there *are* rules, that this is a fight against Slavery, Abolitionism makes it clear that we are following the path we paved from previous Abolitionism which was against more overt forms of Slavery. Therefore, the real condition of Anarchy is the absence of Slavery, where *knowledge* (of rules concerning ownership, responsibility, Rights etc.) is in circulation by the mass public without *fear*, where because there are no slaves, as they have freed themselves, there can be no masters. There is no master plan to such scenario, as no one person gets to decide how everything works for everybody else; therefore, the condition of a stateless society, freedom, cannot be expected to be exactly described by any individual. People will freely and voluntarily make things work without violence, just as they do with everything else outside of politics. Attacks given to *abolitionists* of the past often apply to the *abolitionists* of the present-day.

## **What About Limited Government?**

There can be no such thing as a limit on slavery, as an act of slavery is an act of slavery, the condition of slavery will always manifest so long as the act of slavery is permitted because people are unwilling to recognize slavery as inherently wrong, to be

completely abolished. Therefore, any limit put upon government, as done in history countless times, never works and is simply a waste of time, short of *abolitionism*, what is destined for freedom.

### **What About Hierarchy?**

It is not Slavery, as many people confuse society with government, since they presume Slavery to be natural. Voluntary hierarchies are natural and exists in many places, which is not Slavery, being entirely different from involuntary authoritarian hierarchies based on violence and belief, which is Slavery.

### **A Crime Versus Slavery?**

Slavery is crime guaranteed, happening repeatedly. There will always exist crime, the question is how crime becomes aggregated. Only with government, there is Slavery, and therefore the aggregation of crime, since it is permitted.

*“The highwayman takes solely upon himself the responsibility, danger, and crime of his own act. He does not pretend that he has any rightful claim to your money, or that he intends to use it for your own benefit. He does not pretend to be anything but a robber. He has not acquired impudence enough to profess to be merely a ‘protector,’ and that he takes men's money against their will, merely to enable him to ‘protect’ those infatuated travelers, who feel perfectly able to protect themselves, or do not appreciate his peculiar system of protection. He is too sensible a man to make such professions as these. Furthermore, having taken your money, he leaves you, as you wish him to do. He does not persist in following you on the road, against your will; assuming to be your rightful ‘sovereign,’ on account of the ‘protection’ he affords you. He does not keep ‘protecting’ you, by commanding you to bow down and serve him; by requiring you to do this, and forbidding you to do that; by robbing you of more money as often as he finds it for his interest or pleasure to do so; and by branding you as a rebel, a traitor, and an enemy to your country, and shooting you down without mercy, if you dispute his*

*authority, or resist his demands. He is too much of a gentleman to be guilty of such impostures, and insults, and villainies as these. In short, he does not, in addition to robbing you, attempt to make you either his dupe or his slave.”*

### **Were There Past Abolitionists Who Knew This?**

Lysander Spooner was an abolitionist, anarchist and teacher of Natural Law. He also spoke of how the American “civil war” did not end Slavery. It must be known that it cannot be expected that every abolitionist understood Slavery to the fullest extent, since their ideas were the first of it’s kind, they are not living in an age of mass information and history. The same could be said for the American Revolution, if they recognized that everyone was equal, why did they have slaves? The transition is a timely process, as long as people are putting in the care and effort toward that transition. Supposedly, Jefferson had slaves yet fought slavery, he had government yet fought government; people need other people to understand what freedom is. We can now recognize the full nature of Slavery with no contradictions, if we truly live and act according to principle. Not just the Colonies away from the British, or the Negro living with the Whites, but this time, real freedom and for everybody. Many abolitionists were called quasi-anarchists or "no-government" men by their critics. *Many* different “anarchists” were actually attending meetings, active abolitionists in the 19<sup>th</sup> century, people of names that were not often recognized, like Jeremiah Hacker.

*“All these cries of having ‘abolished slavery,’ of having ‘saved the country,’ of having ‘preserved the union,’ of establishing ‘a government of consent,’ and of ‘maintaining the national honor,’ are all gross, shameless, transparent cheats—so transparent that they ought to deceive no one—when uttered as justifications for the war, or for the government that has succeeded the war, or for now compelling the people to pay the cost of the war, or for*

*compelling anybody to support a government that he does not want.”*

### **How Exactly Do We Put An End To Slavery?**

Courage and persistence of education, as to *WHY abolitionism*. Successful changes in history have always occurred by way of movements, even consisting of as little as 1% of people in a given country. This is however the only time a majority matters in the change of society, as those for past abolitionism were facing the slave-trade almost everywhere in society; the word of morality and ownership had to spread from the 1% to the majority of the population until the overt practice was gone away with in the majority. Movements are based upon ideas. Ideas are backed by awareness and education. A common issue that provided grounded action in many successful movements of the past, was disobeying taxation. This is not the only way, but it does serve as a simple powerful example. If just one community or town got together and committed to not pay any more involuntary taxes, showing why they are doing such to the rest of the world, via the movement of *abolitionism*, it would spark the domino effect of other communities being willing to stop condoning Slavery. If their “own” government is supposedly “by the people, for the people”, what a demonstration it would show that they would use *other* people, man’s law enforcement, to stop their “own” people from being free by use of violence for compliance. If their “own” people are not slaves, then why can’t they freely choose what to do with the products of their own labor. The media or the many people surrounding these communities, with the help of technology, would pick up on this, creating a moment in history to remember. It isn’t the peaceful voluntary community that is the problem, it would be the presumed “authority” of government **initiating violence** upon them with their order-following mental slaves, exposing their own “authority.” This community has every right to self-defense against the self-presumed slave master, by all means possible, as did the slaves who had to free themselves.

People think of economics and other topics as problematic or as solutions, however the moral and principled cause is always at the deepest of roots that determines the rest; from immorality, comes every evil and from enslavement, comes every vulnerability. This isn't a revolution, it is a destined world-wide awakening, where may it be some places recognize this, their next effort would be to share it with other places, make it known everywhere, exactly as done with *abolitionism* in the past. As done by the taxation example for change, the following is a blueprint for *abolitionist* movement change that isn't limited to simply disobeying taxation, a statist action. It is one to *know* of truth, another to *know* of action for the truth. This is created on *my own* behalf to you.

### **The Two Objectives:**

#### ***Knowing Truth (WHY) – Knowing HOW To Manifest Truth***

We should already be grounded upon universal ideas, such as that of equality and Rights, thus the focus should be talking about action. However both are of need, and the main action is to educate. We may stray off course to different ideas, not looking at the more holistic knowledge present. We may at times, only focus on "current news" and we ought to be careful to not simply focus on symptoms, not focusing on action or inspiring others to find what actions they can partake in within their own life. Just alike healing the body, is how we shall heal the world; most people know what they need to do with their own health, they simply need motivation and inspiration to go and do it.

### **The Two Problems:**

#### ***Not Starting – Not Going All The Way***

When we permit wrong-doing, we are not going all the way, this includes talking about the truth in what's happening right now but reinforcing Slavery by legitimizing the system. We cannot make this as an "us versus them" scenario either, because the whole point of dismantling Statism is to say we are all human, we are all of nature, all equal in Rights. We thus must question ourselves and find the answers within Nature; only then, can there be true "unity": mass understanding based on grounded principle.

### **The Main Focus:**

#### ***Not Select People Or Events But Rather Select Relevant IDEAS***

What we focus on, will help in our attraction toward our desired reality. We see in politics the emphasis on promoting "candidates", not only do we see this as problematic in the case of Statism, it is also short-term, not focusing on the

ideas itself, as we assume this one person must carry the ideas for us. Education is ultimately what changes the world. the problem is, knowing Slavery as a definitive concept has not even been presented to the every-day person. If it was at least presented, it's akin to giving someone multiple choices in their health, even if they may be ignorant of them or convinced away from them *at first*. There must be emphasis on those "in the dark", who perhaps need this knowledge the most. We should not form echo-chambers, energy must be transmitted to everyone, a domino effect should be encouraged, this also means real-life action, not simply online, although utilizing all the resources we can, with emphasis on real-life movement-action, which no censorship can defeat.

### **The Main Problem:**

#### ***Slavery (Mental Via Statism)***

Belief, To Unnatural & Immoral (Harmful) Systems – This Is The Great Factor Affecting Our Nature(s), Due To The LACK Of The Main Action.

### **The Main Action:**

#### ***Awareness Of Slavery (In Relation To Rights)***

The Use Of Human Nature (Conscience, Sovereignty, Responsibility) & The Knowledge Of Nature, The Knowledge Of Harm (Evil) Manifestation (Slavery, Democide). Change relies in the masses, not in any select few. This also correlates to simple learning and consciousness. Our intent should be simple, we don't need to want freedom by any other name, we simply want freedom, so we simply shall stand for what IS (truth). Courage for love, conversation for knowledge, responsibility for sovereignty, guidance for freedom. Guidance may even include forming communities and becoming more self-sufficient.

### **The Abolitionism “Movement”:**

#### ***Freedom, Equality, Sovereignty, Humanity, Voluntarism, Nature***

Your Action Creates The Movement & The Movement Creates More Action.

Also known as the one great work. A worldwide, eternal movement. Many outcasts may be skeptical of this because it may entail having shared symbolism or materials or knowledge, but self-input is required and this provides a blueprint for real impact that can also occur quickly depending on the active participants. Not every movement of the past was necessarily perfect in form, as they may have emphasized one individual which ended up getting targeted or depended upon, or their ideas were not universally grounded. When was there ever a movement standing for simply what IS, or addressing slavery in it's fullest. If the “truth” gets out to more people, the job is done as the truth always rises above all, thus there is a level of trust we must have with the process of doing our best in all ways possible.

*The movement created on behalf of my own personal input to this matter is called “Nature Is The Answer” for us to learn about our natural rights, freedom, equality, sovereignty, best summed up through the concept of Natural Law or knowing the nature of Statism and Slavery, of life as opposed to evil.*

*Most can agree that nature is the answer, yet if such is true, man is the question; free by nature, slaves by government.*

### **Questions For Action:**

Can we save humanity through awareness, before we experience harm, via prevention? Is our simple needs being compromised? What would happen if you did not tell the truth that nobody else saw? Are there mindsets telling people “what to think” (by way of propaganda) instead of “how to think” (asking questions like this)? If any alternative arises like there has been, what happens when there exists many, and do they have something in relation to unify and provide grounded direction in the face of one opposing grounded agenda? If you want to make a difference, are you making the difference between the one opposing agenda (Slavery) and the contrary, or the real life versus the illusion? Does having direction and something to aspire to within our personal lives that helps us feel more connected to the greater duty, contribute to our health and happiness, our destiny and passion? Is all that is needed, motivation and inspiration, showing others what change looks like via a movement? Will it be more likely that people are to be courageous or whistle-blowers if they have a movement they can express with? Are we seeking a better tomorrow? If we see a clear as day path and direction for humanity, do we follow it? If at the end of the day, can we all come together and agree upon simple principles of NATURE that are also universal and here to unite upon in their very nature, will we do it? If everyone, everywhere, can come to the same understanding of Right versus wrong or the nature of Slavery, as we are all in the capacity toward it, can there be a message as mission for all the generations to come as a reminder (Nature Is The Answer)? This is not about me or my beliefs projected upon and into the world. Questions that come from this is expected, mystery that comes from not

knowing exactly as to what's to come is also expected. Act on known principle. Ask questions focused on Slavery, supporting individuals coming to their own conclusions. Will we ever be too late? The time is always, to do your best!

### **The Speed Of Change:**

Change can happen so rapidly if we have the courage to truly act on it. If the understanding of Slavery reaches audiences of which are especially already freedom-oriented, a movement can consist of an almost-immediate hundreds, to thousands, to MILLIONS of people. Especially with the nature of one individual sharing to another, and on. It's as simple as the sharing of this material, or the flag of "Nature Is The Answer", for example, whether it be in online locations or real-life locations. This particular flag has a website, which leads to learning about Slavery and freedom. Myself is left out of such on purpose, for we are all the movement, no one person is the movement, with the knowledge standing for itself. *Abolitionism*, the idea, is the main focus. Therefore, the only "joining" is sharing, and thereby sharing education, amplifying efforts of *abolitionism*. The movement simply exists to share the knowledge, to show we are all on the same path, never alone, making organized action easier. Numbers of people are *required*. As long as we share the same knowledge or material, you shall customize everything to your creative expression. The message is the mission, for all generations: Nature Is The Answer. Due to the division created in the world, it is therefore my moral obligation to create unification with this message and mission we share, if we are to stand *any* chance! We may say numbers are required, well what shows those numbers? Actions are not to be simply limited to joining meetings or being active out there, it can be as simple as having a yard sign, one that is totally different from promoting candidates or Statism, as now universal and eternal *ideas* are on the spotlight instead. This movement is voluntarily universal, existing and applying anywhere upon human recognition (contribution) in the need for *abolitionism*, foundational material best unchanged for sake of direction although it will be prone to change. Think of the "do not



tread on me flag" (Gadsen Flag) of 1775 and imagine how much influence it would have, if it had a website in the corner or actually led people to learn about what it truly means; with technology, now it's possible for modernization. People use flags to feel a part of some group, this different type, is simply to bring people toward knowledge. The phrase "Nature Is The Answer" can be a bridge toward *abolition*. The importance is bound to know, and so change, bound to occur.

### **The Three Factors:**

- *Representation (Creativity)*: Ex. Includes a flag. People ought to customize materials to their own liking and speak on behalf of materials from their unique heart. The knowledge and/or movement site is shared, for amplification.
- *Education (Courage, Presentation, Conversation)*: About Slavery, Rights. Those who care the most, will tend to be the *Natural Leaders*.
- *Networking (Guidance, Demonstration)*: Numbers Of People. Rallies may be included, however more impacting with other factors involved. Protests are not necessary, as it is often just begging for change rather than being the change.

### **Also Known As... The Two Main Factors:**

*Integration (Nature) – Promotion (Natural Law, Rights, Health)*  
*aka. Disintegration (Denatured) – Demotion (Slavery—Statism)*

Everyone has different environments, one specific action cannot apply to everyone, but those three factors can manifest in many different forms, applicable to everyone as it is necessary for change.

*The greatest change comes from...  
changing and connecting the minds of people,  
and influencing the culture through creativity.*

### **The Four Steps:**

1. Presence achieved in every community that can possibly be reached (with flag/material)
2. Awareness (education/knowledge) is achieved in at least one community all throughout publicly showing the flag/material

3. *That one community stops committing to a vital Statist act, and defends themselves with force together, if need be (showing WHY from Number 1 & 2: with the flag/material)*

4. *The domino effect occurs and media coverage comes in, areas of the world are changed. The movement carries the message and the mission on to free more areas and to uphold the history and knowledge through generations. The flag/material also stands as a reminder here for WHY such a generation did what they did. Technology can preserve such history EXACTLY as is, to also show WHY, while showing the EXACT SAME knowledge that led to such decisions, in the name of abolitionism. Think of "the people" disobeying, and "their own government" going to stop them? The evil would expose themselves, going against their own populace, and using other human beings to do it too, showing the nature of order-following and the nature of the initiatory-violent system of compliance; so in truth, all we must do is defend who we are, our nature... Nature Is The Answer.*

### **What If Slavery Is Tried?**

Just as overt slavery ("chattel slavery") isn't tried in the general circulation of the world as it is accepted as wrong, covert slavery ("political slavery") will not be tried when it is accepted as wrong. No slave master will succeed without submissive slaves. People will be more on the outlook for it, if it ever persists, since it is a known evil, rather than allowing it to persist because it is seen as legitimate. Presumed "authority" will always claim that some form of violence, or violation of Rights, is necessary for the "common good", as done in the justification for Slavery. It is a sign to pay attention toward, as no wrong action can be turned into a Right by *any* justification. There is no just thing as the *Right to enslave* just as there is no such thing as the *Right to rule*.

### **What Is Care?**

What we care about on a day-to-day basis acts as the driving force of our thoughts and actions, it is generative. What we care about enough, is ultimately what gets created. Whereas, if we do not

care, we are degenerative, unproductive. Care must extend from words to actions. Caring is not simply paying attention toward Slavery, but actively helping people escape mental Slavery, caring to help create an optimal and sustainable future for humanity.

### **What Is Your Responsibility?**

Your monetary “job”, your daily life materialist consumerism, maintaining and validating your ego, “your” select people.

### **What Is Your REAL Responsibility?**

Truth, justice, equality, freedom, health, peace, love, fun and sovereignty for all peoples, above all other so-called “work”. You fulfill a greater purpose to your life, that you can share. Be sure to also support yourself, if you are to support others; however, by supporting others, you also help support yourself. You are not simply responsible for yourself, you are in part-responsible for the world around you, as the peoples always *actually* create it. It is your responsibility to share what you know, that others do *not* know.

### **What Happens When Slavery Is *Gone For Good*?**

No longer will there be interference for voluntarily trading with anyone. No longer will you be interfered with the security of your own home by invaders who are seen as legitimate. No longer will there be any “war” to identify, as no mass amount of slaves will have orders to carry out on behalf of few slave masters. No longer will there be any compulsory government propagandized schooling. No longer will you be summoned by your rulers in their own arbitrary justice system. No longer may you be spied on by government agencies. No longer will people be punished for victimless “crimes.” There will be more variety than ever when it comes to products, medicines, education, media, businesses. Natural medicine can actually be encouraged when it works, with less censorship. Family businesses and farms will inevitably prosper and grow more authentically. Talk about imaginary

country-borders will not matter, as only real property ownership will matter. People and businesses will voluntarily pay for the services that they need, choosing what to do with their own products of their own labor. Family and community will be encouraged as a whole. Hidden knowledge and history will finally come to light. One can speculate long about what will happen, but as done with previous *abolitionism*, if we stick by what we know to be Right, everything will work out and people will make the world work as much as they already do and with even more productivity without violence. Solutions proposed by people will be far better than violently imposed solutions proposed by Slavery. People shall know of that better tomorrow which is totally possible, with their simple effort. This simple effort may seem difficult in a complex world, present of much Slavery, but your standing upon the simple truth is destined to grow overtime as others come to see how important it really is, as you see, yourself. Your efforts will not be forgotten, we are making history by the day, improving upon the past and for the future, a world of more innovation and creativity than ever.

### **What Does It Mean To NOT Be A Slave?**

To not be a slave, is to be sovereign. From Latin adverb *super*: “above” and the Latin noun *regnum*: “ruler-ship.” Therefore, to be sovereign, means to be above the ruler-ship of another, to not have a slave master, as you *know* yourself, you have achieved mastery, control and ownership over yourself.

### **What Does It Mean If You Want Others To NOT Be A Slave?**

You are an *abolitionist*, in the cause for *abolitionism* against all forms of Slavery, as we can define by knowing our *sovereignty*.

*“The pretense that the ‘abolition of slavery’ was either a motive or justification for the war, is a fraud of the same character with that of ‘maintaining the national honor.’ Who, but such usurpers, robbers, and murderers **as they**, ever established slavery? Or what government, except one resting upon the sword, like the one **we now have**, was ever capable of maintaining slavery? And why did these men abolish slavery? Not from any love of liberty in general—not as an act of justice to the black man himself, but only ‘as a war measure,’ and because they wanted his assistance, and that of his friends, in carrying on the war they had undertaken for **maintaining and intensifying that political, commercial, and industrial slavery**, to which they have subjected the great body of the people, both white and black. And yet these imposters now cry out that they have abolished the chattel slavery of the black man—although that was not the motive of the war—as if they thought they could thereby conceal, atone for, or justify that **other slavery which they were fighting to perpetuate**, and to render more rigorous and inexorable than it ever was before. There was no difference of principle—but only of degree—between the slavery they boast they have abolished, and the slavery they were fighting to preserve; for all restraints upon men's natural liberty, not necessary for the simple maintenance of justice, are of the nature of slavery, and differ from each other only in degree.”*

It is very telling that many modern ‘**law enforcers**’ quickly become angry, even violent, when an average citizen simply speaks to the ‘officer’ as an equal, instead of assuming the tone and demeanor of a subjugated underling. Again, this reaction is precisely the same – and has the same cause – as the reaction a slave master would have to an ‘uppity’ slave speaking to him as an equal.”

“The truth is that any form of authoritarian control – any type of ‘government,’ whether constitutional, democratic, socialist, fascist, or anything else – will result in a set of masters forcibly oppressing a group of slaves.”

The concept is so foreign to everything they have ever known and ever thought about, and everything they were taught is necessary and good, that they hardly know how to begin to imagine it. Even our very language illustrates our fear of living in society as free **equals**, because such a state is defined as ‘**anarchy**’ - a term also used to describe chaos and destruction. We have grown so accustomed to the **mental** cage which the myth of ‘authority’ has formed around each of us that most of us are **terrified** of the idea of life without that cage. We are literally **scared** of our own freedom.”

“The life of a caged animal is, in many ways, easier than life in the wild. Likewise, life as an **unthinking** human slave can be more predictable and feel safer than a life of **responsibility**. That is not to say that all people

“Children learn by example. If a child sees his parents always acting as unquestioning subjects of a ruling class, the child will learn to be a slave. But even with each person’s behavior guided by his own imperfect, incomplete understanding of right and wrong, the overall results would be drastically improved compared to the authoritarian alternative, in which basically good people do things they know to be **wrong**, because they feel compelled to do whatever ‘authority’ tells them to do”

Thus substantially all the legislation of the world has had its origin in the desires of one class of persons to plunder and enslave others, and hold them as **property**.”

This may sound far-fetched but i think I can prove it. When the IRS allows you a tax deduction, they and their congressional collaborators and the media call it a tax subsidy, in other words they designate it as a gift to you; a subsidy, the only way they could conceive this terminology is by presupposing that they i.e the government own all the money. Their view is that they're entitled to it all that which they **allow** you to keep, is their compassionate and generous gift, to you. How can this be? You create the money by your efforts, your sacrifice, your creativity, your risk taking, so how can it belong to them? It's very simple, they own you, they **own everything you produce**, your money, your house, your thoughts and ideas, your children. If you go to a foreign country to work you still have to pay the U.S. income tax. You could dig a hole in the middle of Siberia and they'd be entitled to a cut of your wages because in their minds, under their **law**, they own

you. They create arcane and esoteric laws to criminalize you. You can't even understand them without a lot of professional help, you have to run around slavishly collecting little pieces of paper receipts, seven years of detailed financial records because you might be called on to give an account of yourself to the big boss man; and if you've made a mistake, he can take everything you have, he loves it that way, that's total power over you, slavery. In this modern age, the information age, getting your money is not enough, even though money, don't let anyone deceive you, is the material source of your **freedom**. They want your **mind**. If you deviate in your thinking, if you commit one of the ten thousand taboos and they perceive your actions as a threat, they'll come out and kill you. It was the thought police who killed the children at Waco and ruby ridge. **We're not free, we belong to the government**. Who else holds a counterfeit license to kill, incarcerate and confiscate for **non-crimes**. Remember, America is about liberty first and last, not **obedience** to bureaucrats. The Washington power-click wants you to shut up, get in line, do what you're told to do and most outrageously, think what you've been told to think. We have hundreds of politicians and thousands of lobbyists crawling all over Washington thinking of ways to control you, to extend **their will over you**, to subvert your freedom and replace it with their will to capture, that is to **steal**, your life force and so we should all be very angry, because anger is the engine that drives our will to resist and without resistance, without awareness, they will take it all. It's not just politically perverse, it's a sin against mankind because freedom is actually sacred. Drop an ant into a jar and seal the lid, it will spend the rest of its life trying to get out, it has nowhere to go, but it wants to be free, that is its **nature**. It's the way every living thing is made, once a long time ago, I saw something at the zoo, a wolf lying in its cage i thought about how this magnificent animal was the end product of millions of years of evolutionary design, a nose that could detect the faintest scent, ultrasonic hearing, eyes that could see in the dark, teeth and jaws capable of crushing thick bone, heart and lungs that could run him for hours in a sub-zero blizzard



and yet there he was, lying forlorn and full of despair. He was well fed he had a clean habitat and water and medical care, so what was the problem? He was sick with the **knowledge** that his wonderful powers would never be **exercised** again, and so he lay there, his head on his paws, staring blankly ahead at perhaps some imaginary forest that he could never reach because there were bars around him, they had not killed his body but they were destroying his soul. God gave Adam and Eve freedom even though he knew they would invite death into the world, that's how important freedom is in the divine scheme of things and that's why we urge you to **defend** it.”
